I) Call to Order, Invocation, Roll Call

Mayor Ric Hall called the meeting to order. Councilman Torre' Mills gave the invocation. Also present were the City Attorney, Tommy Coleman, and the City Clerk, Melinda Crook and the Utility Director, Charles Jenkins.

III) Approve Minutes

A motion was made by Councilman Charles Middleton and seconded Councilman Torre' Mills to approve the January 5th Minutes. The motion carried.

V) Administrative Committee Reports

Beer License Willie C. Cawthon Jr. A motion was made by Councilman Charles Middleton and seconded by Councilman Torre' Mills to approve the Beer License for Willie C. Second Reading and Adoption of Ordinance Amending the Traffic and Vehicles Ordinance A motion was made by Councilman Charles Middleton and seconded by Councilman Andy Smith to approve the Ordinance Amending the Traffic and Vehicle Ordinance. The motion carried.

Tax Anticipation Loan A motion was made by Councilman Charles Middleton and seconded by Councilman Torre' Mills to approve the bid from Bank of Early at 3.25% for the \$400,000 Tax Anticipation Loan. The motion carried.

The Council was given their financial reports. The Clerk informed the Council that bills for the month of February would be late due to computer problems.

VIII) New Items Proposed By Mayor and City Council

The Utility Director gave the Council updates on all the projects going on in the City (Sewer work, Treatment Plant work)

The Mayor brought to the Council the need to replace the roof on the City Annex and asked the Council to allow getting quotes not to exceed 10,000. A motion was made by Councilman Andy Smith and seconded by Councilman Charles Middleton to approve getting quotes and to replace the roof on the City Annex not to exceed \$10,000. The motion carried.

The Mayor brought to the Council that the City had gotten a quote from Williams and Son, not including the drain, on the repairs to the Pool House for the Rec. Dept. and that he had not gotten any information from the Rec. Director as of yet, but that he would recheck with the Rec. Director. A motion was made by Councilman Torre' Mills and seconded by Councilman Charles Middleton to approve the City going with their quote plus getting a pool company to replace the drain and deducting it from the Rec. Dept. budgeted amount if no other quotes have been provided. The motion carried.

A motion was made by Councilman Charles Middleton and seconded by Councilman Torre' Mills to re-nominate Councilman Al Hutchins to the RDC Board. The motion carried.
