**I) Call to Order, Invocation, Roll Call**

Mayor Ric Hall called the meeting to order. Councilman Torre' Mills gave the invocation. Mayor Ric Hall, Councilman Torre' Mills, Councilman Al Hutchins, Councilman Andy Smith and Councilman Charles Middleton were all present. Also present were the City Attorney, Flynn Coleman, the City Clerk, Melinda Crook and the Utility Director Charles Jenkins.

**III) Citizens and Delegations**

**Carolyn Adams – High Utility Bills** Not Present

**Darrell Alexander – Community Development Project**

Mr. Alexander came before the Council to inform them of the Community Development Project that would create job and help stimulate growth. He informed the Council that this was a faith based non-profit project. He informed the Council that there would be grant funding. This project would include medical & dental facilities, day care, recreation center, shelter for the homeless, a domestic violence center, assistance to the elderly, such as meals on wheels and others areas of community assistance.

Paul Simonton was present and gave a slide presentation to the Council showing where the Water Treatment Plant was to where it is at the present time after most of the work being completed. He then answered questions from the Council and public.

**Request To Move Two Trailers from Tall Pines Trailer Park** There was discussion between the Council on the situation of trailers that are over 15 yrs old and have to be moved from trailers parks due to property owners tell them to vacate. There was discussion with the public. The Council determined that at the present time with the present ordinance the City could do nothing to assist in this situation.

**Public Safety Budget** The Council tabled this item to readdress at the next meeting.

There was discussion between the Council regarding the progress of the Swimming Pool.

There was discussion between the Council on the Community Meeting that was held regarding the Civic Center and some of the suggestions that had been present. Councilman Mills informed the Council that he would get more information and recommendations together to bring back to the Council.
